1) **RECOMMENDATION**

The Licensing Subcommittee recommends that the Legislature grant the Department of Licensing general rulemaking authority over the self-certification program to better clarify what level of autonomous vehicle is required to self-certify with the agency prior to testing vehicles in Washington State.

RCW 46.92.010 Testing—Self-certification pilot program

(8) The department may develop rules for the purpose of administering and maintaining the self-certification pilot program.

2) RECOMMENDATION DESCRIPTION, CHALLENGES, AND MITIGATION

Washington should clarify what SAE level of autonomous vehicle the self-certification process is intended to apply to. Based on research and industry feedback, the assumption is that the self-certification program is intended to be for SAE levels 4 and 5, however this is not explicit in Executive Order 17-02 or Engrossed Substitute House Bill 2676. The Department of Licensing could accomplish this clarification through rulemaking, if given the authority from the Legislature. While not required, it could also be helpful if the Legislature granted DOL general rulemaking authority around the self-certification process to make this authority more clear.

Recommended Remedies:

The Licensing Subcommittee recommends a legislative change to RCW 46.92.010 to grant general rulemaking authority to define the SAE levels for the self-certification pilot program.
