There are many questions surrounding automated vehicles (AV): infrastructure, liability, data access and privacy, and others. We recognize an additional need to understand the less obvious implications of the transition to AV, particularly around public health and equity.

Members of the AV Safety Subcommittee **recommend that an additional subcommittee be created to specifically address broader health and equity implications beyond the safety scope** in order to inform decisions, provide strategies to maximize the positive impacts, and develop mitigation strategies for any foreseeable negative impacts. We recommend this new subcommittee be implemented as soon as possible.

Goal: To ensure fulfillment of the requirements of Substitute House Bill 2970 and fully support the Autonomous Vehicle Work Group, a primary goal of this new subcommittee is to ensure the benefits of automated mobility are equitably distributed and that negative impacts are not disproportionately borne by traditionally marginalized communities. (Washington State Department of Health would provide staffing to the newly formed subcommittee).

Scope: The AV Health and Equity subcommittee would define its role in collaboration with the co-chairs from other sub-committees. They will consider focusing health and equity in relation to: air quality, water quality, noise, green space, mental well-being, physical activity, safety, social connections, and emergency medical services, and ensure engagement from disadvantaged communities, prioritizing communities of color

The scope of this new AV workgroup subcommittee would include:

- Defining health and equity and considering tools consistent with those called for in Washington's Transportation Plan 2035: "Develop a Transportation Equity Analysis toolkit for use in evaluating the benefits and impacts of transportation policies and investments on historically marginalized populations in Washington."
- Health and equity impacts resulting from changes to commercial vehicles, mass transit, shared fleets and private ownership.
- Health and equity impacts resulting from changes that will occur when AVs are first introduced into an environment that will still mostly be comprised of traditional vehicles.
- Health and equity impacts resulting from changes that will occur when AV become very common on our roadways.
- Health and equity impacts resulting from changes that may be made to accommodate Highly Autonomous Vehicles in the future.
